TERMS & CONDITIONS

- 1. The Haj packages rates are calculated per Haji / pilgrim on current rate of US Dollar rates @ Rs 83/- per Dollar and Saudi Riyal @ Rs 23/-. If there is any increase in US Dollar / Saudi Riyal / Visa Fee / Flight Ticket rates / Repeater fee etc then the difference will be added on Packages.
- 2. Airlines Economy Class Group tickets & Approved Haj Visa are non refundable and not transferable. The travel date or Airlines or Hotels in Makkah and Madinah are subject to availability. (Ticket of Business class or first class or upgradation differences is required to pay by pilgrim).
- 3. Haji must pay Haj packages cost with compulsory Govt. GST Tax 5% and TCS 5% for below 7 lakh package. 20% TCS for above 7 lakh. (The pilgrim / Haji will get TCS refund by Filing Income Tax Return).
- 4. Air conditioned Buses for all transports and transfers are allotted by the Moallim, and Govt. of Saudi Arabia, not by HGO, the details of transports are mentioned below:-

A. Jeddah Airport to Makkah Hotel by bus.

- C. Mina Tent to Arafat by bus.
- E. Muzdalifah to Mina Tent or Jamarat by Walking / On Foot.
- G. Makkah Hotel to Madinah Hotel by bus.
- F. Tawaf e Ziyarat by Walking / On Foot.

B. Makkah Hotel to Mina Tent by bus.D. Arafat to Muzdalifah by bus.

- H. Madinah Hotel to Madinah Airport or Jeddah Airport by bus.
- 5. Hotel accommodation in Makkah and Madinah are sharing basis of 4 to 5 bedded commonly per room. Separate room of 3 bedded or 2 bedded charged extra. Pilgrims should carry veil / pardah cover, if required.
- 6. The Pilgrims should carry light luggage (30 Kg divide in 2 checking luggage and 7 Kg in Hand baggage) to avoid extra burden and air lines charges. Also for Mina & Arafat Hajjis should carry light and small portable hand baggage.
- 7. The female pilgrim should accompany their Mehram. Full package rate will be charged for any age of children.
- 8. Any Aqama person or any relative or any guest of pilgrims / Hajjis will not be entertained in the Hotels room or Hotels restaurant or Mina or Arafat. They can meet in reception counter with consent of Group Leader.
- 9. We purchase quality food from Saudi Govt. Authorised caterers or hotels management and the food menu and meals served in buffet breakfast, lunch & dinner in Makkah, Mina Tent, Arafat and Madinah will be common for all pilgrims. There will be no arrangement of food in Makkah hotel during 5 days of Haj
- 10. The Pilgrims should maintain food timings & cleanliness at the restaurants. No food or plates will be allowed to be taken in the rooms.
- 11. Allocation of Hajj License to HGO (Hajj Group Organiser) depends on Ministry of Minority Affairs (MOMA), Government of India, if in case the Hajj Quota is not allotted in proper time or not issued, the refund of booking amount will be given in several instalments.
- 12. The formation of new rules and regulations by Ministry of Minority Affairs (MoMA) Government of India and Kingdom of Saudi Arabia related to groups of HGO as CHGO (Combined Haj Group Organisers) as Lead or Non Lead groups for Cluster or allotment of Tents in Mina / Arafat etc may apply on Haji / pilgrims.
- 13. The HGO (Hajj Group Organiser) and CHGO (Combined Haj Group Organisers) will assist the pilgrim for better services during 5 days of Haj rituals, the Mashaer Services like allotment of Mina tent zone wise / buses / Arafat Tent / food / Jamarat rumi timing / check out from Mina on 12th Zil Haj and other services under the management of Tawaf Companies / Moallims / Ministry of Hai the Saudi Government.
- 14. Checking out from Mina after Jamarat Rummi on the 12th Zil Hajja before Maghrib is very difficult because of heavy rush, so the Hajjis can walk / on foot with the group for Makkah hotel or can make own arrangement to reach Makkah hotel.
- 15. The Hamdaan Travel Services (HGO) will not undertake any liability towards any loss / damage of life / property or any belongings what so ever / untoward accident / natural calamity / any war
- 16. Cost of Haj packages rate differences are based on peak season and higher airlines fares.
- 17. The Hamdaan Travel Services (HGO) have all the rights to change the travel date, time, package rates, flight, hotel accommodation, foods etc, at any time of the year view to some unfavourable circumstances what so ever if happened.
- 18. Elderly or physically unfit or disable or having chronic disease Haji should accompany one helping person and wheel chair at their own cost. The test of RT-PCR / Infected Disease / Restricted Disease report found positive in India or abroad, there will be no refund of Haj Package.
- 19. HGO / CHGO provide Haj services following the principle of "caveat emptor". Hajjis must take Haj rituals / orientation / training / required vaccinations / sign tripartite agreement and Haji should give feedback through "Govt. "Haj Suvidha" mobile app.
- 20. It is important for each Haji to be respectful / politeful to each other during the whole Haj journey.
- 21. Booking form point number 16 must be settled by the tour operator before travel.
- 22. Sponsorship declaration required in case of relative or third party payment on behalf of Haji, the GST or TCS refund can be claimed only by Haji after filling Income Tax Return; the sponsor will not get GST or TCS refund / claim as per Income Tax law.
- 23. All the pilgrims / Hajis are advised not to carry inflammable, narcotics, excess quantity of medicines or banned items into the Kingdom of Saudi Arabia, if any pilgrim found carrying banned items, will be liable for legal action as per Saudi Law.
- 24. 100% non refundable, if pilgrim cancel their Haj trip before travel date or after the completion of Haj booking formalities including Hotels / Ticket / Visa / Transportation / Mina Tent / Arafat tent etc.
- 25. Any services beyond the terms & condition of Haj packages are subjected to availability and additional cost.
- 26. Any dispute related to facilities / services subject to the Jurisdiction of the courts of Kolkata.
